NOW THIS DEED OF TRUST WITNESSTH AS FOLLOWS

1. This Trust shall be known by the name '**AMRATHA BHARATHI TRUST**', (hereinafter called the TRUST) and the principal office of the Trust shall be situated in Hebri in the State of Karnataka for the time being and may be transferred to such other places as the Board of Trustees may decide from time-to-time.
2. i. The Administration, execution and management of the Trust shall vest with the 'Board of Trustees' constituted by the Trustees for the time being of the Trust.
ii. The 'Author of the Trust' hereby appoint the following persons as the first Trustees of the Trust subject to such duties, powers, liabilities and/or other conditions specified herein.
 - a. **H. BALAKRISHNA MALLYA**, son of Late H. Damodar Mallya, aged about 65years, residing at Kuchoor, Hebri, Karkala Taluk, Udupi District.
 - b. **H. SATHISH PAI**, son of H. Anandraya Pai, aged about 47 years, residing at Hebri, Karkala Taluk, Udupi District.
 - c. **H. YOGISH BHAT**, son of H. Ramesh Bhat, aged about 46years, residing at Hebri, Karkala Taluk, Udupi District.
 - d. **H. GURUDAS SHENOY**, son of H. Radhakrishna Shenoy, aged about 42 years, residing at Hebri, Karkala Taluk, Udupi District.
 - e. **H. SUDHIR NAYAK**, son of Late H. Panduranga Nayak, aged about 46 years, residing at Hebri, Karkala Taluk, Udupi District.

3. The objects, aims or purposes which the Trust shall execute, or conduct are :
- Extending or assist in extending financial or other help through granting Donations, Scholarships, Awards, Maintenance, Contributions and/or Prizes to the economically poor or backward people in general and to the physically handicapped persons, victims of natural calamities, journalists, writers, artists in particular and/or the members of their family who are poor;
 - Maintaining or assist in maintaining public health through establishing, running or managing Health Centers, Dispensaries, Medical Camps, Nursing Homes and/or Hospitals for the benefit of Public;
 - Spreading or assist in spreading knowledge and education through establishing, running or managing Educational Institutions such as Schools, Colleges, Training Centers, Libraries, Reading Rooms, etc., for the benefit of public;
 - To establish , maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and to aged persons.
 - To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
 - To grant relief and assistance to the needy victims during natural calamities like famine, earthquake, flood, fire etc.
 - To create national forum for exchanging views and experience of social workers, social work, education, deadly diseases and social and other activities.
 - To organise youth and woman for enhancing their qualities of life and

7. The Trust and Trust funds shall be and irrevocable for all times.

8. DUTIES, POWERS AND LIABILITIES OF THE 'BOARD OF TRUSTEES':

- a. The Board of Trustees shall be constituted by the Trustees for the time being and shall manage, conduct, execute or otherwise further the objects of the Trust.
- b. The Board of Trustees shall possess the Trust property upon Trust and manage and maintain the Trust property and utilize the income of the Trust only for the purposes enumerated herein.
- c. The Board of Trustees shall in the normal course meet and decide unanimously or by majority vote, any business or affairs of the Trust. However, in the case of urgency, if the meeting of the Board of Trustees cannot be conveniently held, any decision may be adopted through circulation of papers. The quorum for the meeting shall be **Five**. The Board of Trustees shall keep or cause to be kept a Minute Book containing the proceedings of their meetings.
- d. The Board of Trustees may invest the Trust funds in such securities or properties as they deem fit and proper and in conformity with the provisions of Section 13(5) of the Indian Income-Tax Act, 1961, from time to time and/or alter, substitute, exchange, acquire or dispose off or otherwise deal with the Trust property. However, the Board of Trustees shall not invest the Trust funds in the securities, which are repugnant to the provisions of Section 13(5) of the Indian Income-Tax Act, 1961.
- e. The Board of Trustees may receive, acquire or possess any assets, properties or interest in immovable properties for the purposes of conducting the activities of the Trust by way of transfer, purchase, gift, lease, hire or otherwise and may dispose off, alter, substitute or otherwise deal with such assets and properties;
- f. The Board of Trustees may receive or accept and acknowledge the receipt of any donations, contributions, endowments, gifts or transfers made by any person in favour of the Trust.

- i. To do such other activities necessary and incidental to execute the above-mentioned objects and to manage or administer the affairs of the trust, as the 'Board of Trustees' may decide from time to time. However, such activities shall be in conformity with the provisions of the Indian Trust Act, 1882 and the Rules made there under and the Indian Income-tax Act, 1961 and the Rules made there under or any statutory modifications thereof.
4. The 'Board of Trustees' shall hold the assets and properties of the Trust whether movable or not (hereinafter called the 'Trust property') upon trust and in the name of and on behalf of the Trust. The Trust property shall include
- a. The sum of Rupees One Thousand (Rs. 1000/-) only settled by the 'Author of the Trust' as nucleus of the Trust.
 - b. Such assets and properties donated, gifted, settled or transferred to the Trust by any person with a specific direction as to its use; however, such direction shall be for charitable purpose(s) only.
 - c. Such assets and properties purchased, acquired or possessed by the 'Board of Trustees' for and on behalf of the Trust from time to time and any accretion, addition, variation or improvement made to trust property.
 - d. Excess of income over expenditure of the Trust.
5. The income of the Trust after meeting or providing for all the administrative and contingency expenditure of the Trust shall be utilized only for the execution and furtherance of the objects of the Trust. Income of the Trust means and includes:
- a. Such donations, contributions or settlements made to the Trust without any specific direction as to the use, by any person
 - b. Such income generated from the agricultural property owned by the trust and
 - c. Such interest, dividend, rent, hire, profit, gain or income received, accrued or earned by the Trust on the Trust property.
6. This Trust shall be a wholly charitable institution and the benefit of this Trust shall be ensured to the entire public irrespective of caste, creed, religion or sex.

- g. The Board of Trustees may borrow funds required for the purposes of the Trust from any sources upon such terms and conditions as they deem fit and proper and may pledge, hypothecate or have a charge over Trust property as a security for such borrowings.
- h. To apply to the Government, public bodies, urban, local, municipal, district and other bodies, elected representatives, corporations, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with a view to promoting the objects of
★ the Trust and to discuss and negotiate with the government Departments, public and other bodies, corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to confirm to any proper condition upon which such grants and other payments may be made.
- i. The Board of Trustees may have an appropriate account(s) in the name of the Trust, with any Bank(s), Banking Company(ies) or Financial Institution(s) and such an account shall be operated by the Managing Trustee and any one of the two trustees appointed by the Board of Trustees jointly for and on behalf of the Trust.
- j. The Board of Trustees may appoint such staff and personnel for the Trust, under such terms and conditions to be specified in the order of appointment and may terminate, suspend or otherwise deal with such staff and personnel.
- k. The Board of Trustee may authorize one or more of the Trustees to represent the Trust in any circumstances and may delegate such power, duties and responsibilities as they deem fit.

- l. The Board of Trustees shall keep or cause to be kept proper books of accounts and documents showing true account of all the receipts received and payments made on behalf of the Trust. Such books of accounts of the Trust shall be closed on 31st March every year and final statement of accounts such as Receipts and Payments Account, Income and Expenditure Account and Balance Sheet etc., of the Trust for that year shall be prepared. Such final Statements of Accounts of the Trust must be audited by a Chartered Accountant to be appointed by the 'Board of Trustees' every year.
- m. The Board of Trustees may appoint any one of the Trustees to be the Managing Trustee of the Trust for such period and may delegate him such powers, duties and responsibilities as may be decided.
9. **THE DURATION, TERMINATION AND APPOINTMENT OF THE TRUSTEES:**
- a. The Trustees appointed hereby and/or hereafter shall be Trustees for their life.
- b. The Trusteeship of the Trust shall be honorary and no Trustee shall be entitled to receive any remuneration as Trustee. However, each Trustee shall be indemnified by the Trust while acting as a Trustee. The Trust shall reimburse any reasonable expenses incurred by the Trustee out of his funds for and on behalf of the Trust.
- c. The Trusteeship of any Trustee shall be deemed to have ceased on his
- Death.
 - Notified legal incapacity.
 - Resignation tendered in writing addressed to and served on and accepted by the Board of Trustees.
 - Expulsion or removal from trusteeship for acting against the interest of the Trust, by a decision adopted with not less than two-third majority vote in favour, in a meeting of the remaining trustees of the Trust; however, before adopting such a decision, the said trustee shall be given an opportunity of hearing.
- d. If trusteeship of any Trustee ceases, the office bearer-ship, if any, held by such Trustee shall also cease.


- e. In case trusteeship of any Trustee ceases, the vacancy shall be filled by appointing other suitable person by a decision adopted with majority vote in favour, by the remaining Trustees of the Trust.
- f. The Board of Trustees may co-opt additional Trustees. However, the total number of Trustees shall not exceed eleven at any time.
10. The Board of Trustees may dissolve the Trust, by a decision adopted with not less than two-third majority vote in favour, for the reason either the objects of the Trust cannot be carried on effectively or trust would be better served by merging or amalgamating with any other charitable trust or Institution and which enjoys recognition under Section 80G of the I.T. Act 1961 as amended from time to time. In case of dissolution of the Trust, the surplus of Trust property after meeting or providing for all the liabilities of the Trust as on the date of dissolution, shall be donated to such other charitable trust(s) or institution(s) as may be decided in the meeting in which a decision for dissolution will be adopted and in no case the Trust property shall be distributed to or among the Trustees of the Trust.
11. In the event of any dispute or difference arising as to affairs of the trust, which board of trustees will be unable to resolve among themselves, a team consisting of Vibhag Sangha Chalak, Vibhag Karyavaha and Vibhag Pracharak of Rastreeya Swayamsevak Sangha, Udupi District shall be appointed as arbitrators and their decision shall be final and binding on the Trust and the same shall not be called in question.
12. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.




13. Further no amendment shall be carried out without prior approval of the Commissioner of Income Tax.
